This service will be invoiced separately to you utilizing a Change Order.

Service Guarantee

If you are not completely satisfied with the services performed by Erik Mosich & Associates, Inc. we will, at your option, either refund the price, or accept a portion of said price that reflects your level of value received. Upon final payment of your invoice, we will judge you have been satisfied.
